ABOUT THIS TAB SUMMARY: Due to fires in Los Angeles in January of 2025, numerous teams had to drop out of Beach Party 2025 within a few days of the event. As a result of these drops, we deviated from our usual bracket structure and instead used a traditional AMTA pairing process, with a twist for Round 4. After the conclusion of Round 3, we took the top two needs Plaintiff and the top two needs Defense teams and had them compete in one of two Championship Rounds, which featured a panel of three jurors and a presiding judge. All ballots counted toward outcome and were divided by two to align with the 2-ballots-per-round counted standard for the event, which prevents distortions in CS for other teams. When counting individual awards, this process produces fractional ranks for students, which is why some students do not have whole-numbered ranks while being ranked within the 20-point scale. One notable consequence of this structure was that Texas A and UCLA A faced each other in final round, despite previously competing with each other in Round 3 of this event on opposite sides. This was necessary to ensure that Texas A was not paired with Riverside A – their Round 2 opponent who they had also faced on the same side, but who was ranked D1 at the end of Round 3.
